Eligibility

All artists currently living in Ohio, Michigan, Indiana, Kentucky, West Virginia, western Pennsylvania, western New York, and Ontario, Canada, working in all media of sculpture, installation, and expanded media are eligible. Open to students.

Parameters

Artists may submit up to 3 works that are no larger than 3 x 3 x 3 feet (all dimensions added together) and no older than 3 years. Video work with a sculptural component may be submitted. The sculpture can be for exhibition on the floor, a pedestal, and the wall, or as a ceiling suspension if it is lightweight. The work cannot have previously been exhibited in northeast Ohio (with an exception for student artworks). Artists are responsible for shipping, insurance en route, and difficult installations. The Sculpture Center fully insures all artwork while on its premises.

Juror

Sara O'Keeffe is an Associate Curator at the New Museum. She was part of the curatorial teams that organized "Trigger: Gender as a Tool and a Weapon" and the "2015 Triennial: Surround Audience". She curated "RAGGA NYC: All the threatened and delicious things joining one another" (2015) and "Screens Series: Dynasty Handbag" (2018-2019), and co-curated "Jeffrey Gibson: The Anthropophagic Effect" (2019); "MOTHA and Chris E. Vargas: Consciousness Razing—The Stonewall Re-Memorialization Project" (2018-2019); "A.K. Burns: Shabby but Thriving" (2017); "My Barbarian: The Audience is Always Right" (2016); "Beatriz Santiago Muñoz: Song, Strategy, Sign" (2016); "Cheryl Donegan: Scenes and Commercials" (2015-2016); and "Wynne Greenwood: Kelly" (2015), all with Johanna Burton.
